12 Stones Guest Farm LLC Rental Agreement and Regulations

- 1. CHECK IN TIME IS AFTER 4 PM CST AND CHECK OUT IS 11 AM CST. No early check ins or check outs unless previously arranged with host. This agreement does not create a tenancy or residence. You must depart at the agreed date and time.
- 2. This is a NON SMOKING property. If you smoke you will be asked to leave without a refund.
- 3. Pets are not allowed on property.
- 4. We will not rent to vacationing students or singles under 21 years of age unless accompanied by an adult, guardian or parent.
- 5. Damage deposit: If you have not booked through one of our online services (i.e. : VRBO, Airbnb), upon your arrival, we will need to record a credit card number in the event that damage occurs to the property during your stay. The card is not utilized provided the following provisions are met

a. No damage is done to the home or its contents, beyond normal wear and tear.

b. Prior to your departure, all debris, rubbish and discards are placed in the outside trash can and soiled dishes are washed and placed in the drying rack. Used sheets are removed and left in a pile on top of the beds they came off of. Fold blankets separately and leave on bed as well.Place dirty towels in wicker basket in the bathroom

- c. All charges accrued during the stay are paid prior to departure.
- d. No linens are lost or damaged.
- e. No early check in or late check out, unless arranged in advance.
- f. The property has not been smoked on.
- g. The renter is not evicted by the owner or the local law enforcement.
- h. There is no damage to the hot tub cover from children or others sitting on top.
- 6. Payment and cancellation policies are detailed in VRBO and AirBnB pages.
- 7. MAXIMUM OCCUPANCY: The maximum number of guests is limited to 6 unless special authorization is given by the owner for additional guests.
- 8. House parties and illegal substances are strictly prohibited and are grounds for immediate eviction.
- 9. This property requires a two night minimum stay.
- 10. INCLUSIVE FEES: Rates include a one-time linen/towel set up. Owner shall provide utilities, furniture, fixtures, linen, and towels.
- 11. NO DAILY MAID SERVICE: while linens and bath towels are included in the cabin, daily maid service is not included in the rental rate. We suggest you bring beach towels if going to the creek, lake or water park. We do not permit towels or linens to be taken off the property. You have full use of laundry facilities.
- 12. RATE CHANGES: Rates, terms, and conditions subject to change without notice. Rates are locked in once the reservation is confirmed.
- 13. FALSIFIED RESERVATIONS: Any reservation obtained under false pretense will be subject to forfeiture of advance payment, deposit, and/or rental money, and the party will not be permitted to check-in.
- 14. WRITTEN EXCEPTIONS: Any exceptions to the above mentioned policies must be approved in writing in advance.
- 15. LIABILITY: Owner shall not be liable to Tenant, Tenant's guests, licensees, or invitees or any other person for any injury, illness, accident, loss, or damage to any person or property in the cabin or on the property. Tenant shall hold Owner harmless and indemnified from and against all loss, injury, or damage occasioned by the use or misuse

of any part of the premises, parking area, creek, pastures, hillsides, woods, or community, and from or against any omission, neglect, or default of Tenant, his/her guests, licensees, or invitees.

16. CREEK: Swan Creek is a year round creek, but please note that waters rise quickly in the creeks in this region during and after a rain and the undercurrent will be swift. Please use extreme caution at all times in the creek and do not attempt to enter a creek or cross when the water has risen and/or is traveling swiftly. Children are not to use the creek without adult supervision. Please plan for your safety and remember that a cell phone may not get reception in the hills, valleys and bluffs of the Ozarks.
